KHS PROVIDES 24/7 EMERGENCY ANIMAL RESCUES & ANIMAL MANAGEMENT SERVICES FOR THE COUNTY OF KAUAI. IN 2008, 1,121 HOMELESS PETS WERE ADOPTED TO LOVING HOMES COMPLETE WITH HEALTH & BEHAVIOR CARE, STERILIZATION SURGERY, A MICROCHIP & TRAINING INFO. 833 LOST PETS WERE REUNITED WITH THEIR FAMILIES & MICROCHIPPED. KHS PROVIDED 1,524 FREE STERILIZATIONS & \$5 MICROCHIPS FOR PETS BELONGING TO LOW INCOME FAMILIES & CAT CAREGIVERS. OUR NEW FELINE MOBILE SPAY/NUETER VAN PERFORMED SURGERIES AT 6 ISLAND LOCATIONS.
